# Oil Machinery Trade

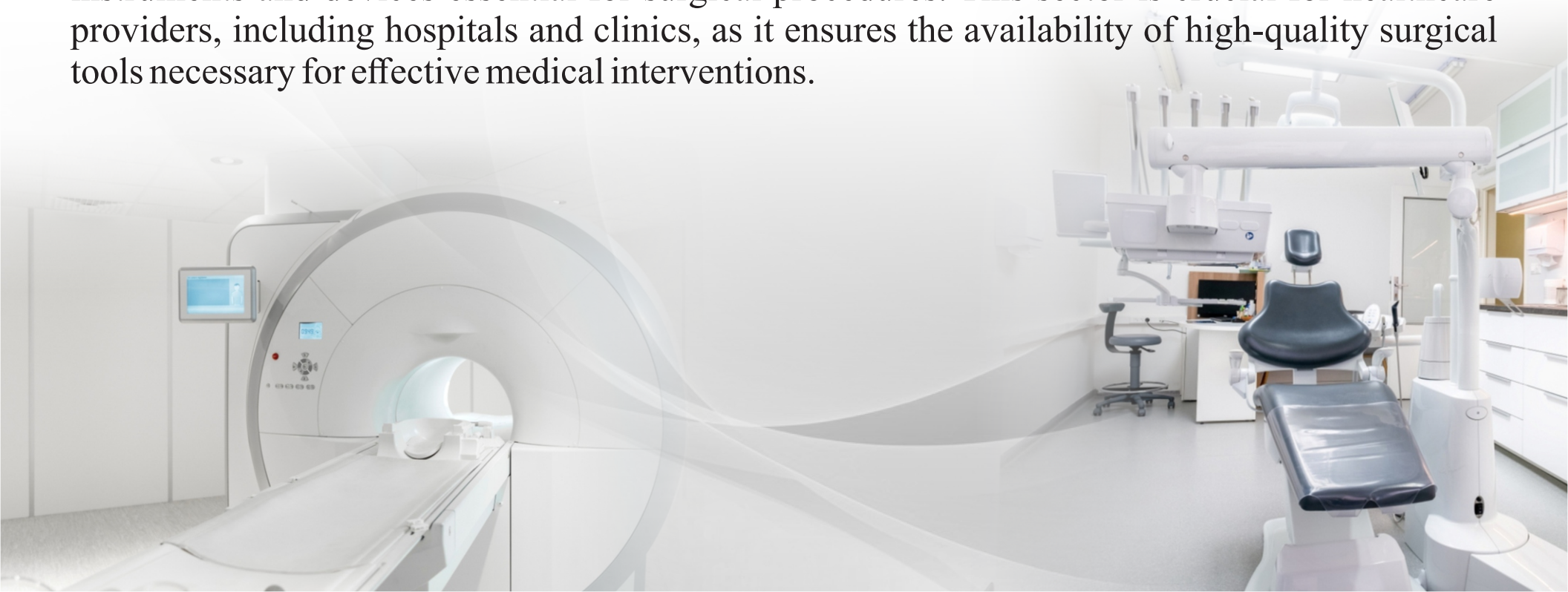
